Questions and a short media release form will be provided prior to the training.
- B) PARTIAL SCHOLARSHIP (Depending on need):** Provide a **work exchange** by arriving by 7am, an hour early, and stay until 5pm, a half an hour later, both days to help our trainers with set-up and break-down of the training in addition to other set-up and break-down related tasks.

## Option A: ONE PAGE WRITTEN TESTIMONIAL

Provide a **one-page written testimonial** with supporting youth quotes, and/or photographs of youth in the Girls Circle or Council programs to be completed and submitted to One Circle Foundation within 45 days after the training.

Any quotes or photos shared by or including youth require adherence of your organization or agency's set media release policy.
